# LEGAL INITIATIVE. ACTIVITY REPORT FOR 2023



## **Legal Initiative** is a Belarusian human rights organization that has been working to protect human rights since 1996.

Legal Initiative operated domestically up to 2021. Activities included monitoring the trials and the military, human rights courses and training, making submissions to the UN Human Rights Committee, promoting human rights through quizzes and quests, and making human rights films and videos.

Belarus faced record levels of violence in 2020 after protests sparked by fraudulent presidential elections. Between August 9 and August 12 alone, the authorities detained 7,000 peaceful protesters. In response to the wave of violence, the Legal Initiative founded the <u>International Committee for the Investigation of Torture in Belarus</u>, a special project that aims to document as many cases of torture as possible and preserve all evidence of the regime's crimes.

In 2021, Legal Initiative had to flee Belarus and continued to operate from Lithuania. Here we continue to carry out education and outreach work, and to help people who have survived torture and ill-treatment at the hands of the Belarusian regime.

#### **EDUCATION**

We believe that respect for human rights is only possible in a country where everyone knows their rights. That is why education is one of the key areas of the Legal Initiative's work.

#### **Human Rights Course**

Every year we organize several streams of the Human Rights Course. The goal of the course is to teach activists and prospective human rights defenders the basics of human rights theory. On average, there are **15 participants** in each intake. Each course consists of **3 sessions of 3 days** each.



#### **Human Rights in Action**

In 2023 we launched a new program — the School of Human Rights in Action. It is an annual program of **6 modules** that offers theory (in-depth study of human rights) and practice (internship in a human rights organization or implementation of your own project). In addition, students are required to submit homework assignments, attend additional online sessions between classes, and use an online platform with a database of supplemental materials.

Human Rights in Action is an advanced level program for those who are already familiar with the concept of human rights, want to learn more and are ready to take real action for human rights to be respected in society. Its goal was to strengthen the Belarusian human rights sector and train new practitioners and professionals.

#### Alumni Club "Initiate"

It is important to us not only to introduce people to the concept of human rights, but also to help our alumni grow in this field. That is why this year we launched the "Initiate" Alumni Club.



The goal of the club is to help alumni build their own careers in the field of human rights. As part of the club, we offer additional webinars and trainings that help delve deeper into the field of human rights, as well as a weekly newsletter with educational and career opportunities.

#### **FilmTrainings**

We are constantly looking for new formats and approaches to engage more people in the defense of human rights. That is why this year, in addition to the main schools, we organized Film making Trainings. Our goal was to engage people who are not yet familiar with human rights through creative activities.


#### Alumni activities

#### Video content



#### The Week against Torture

Between June 20 and 26 we held the Week against Torture — a series of events dedicated to the International Day in Support of Victims of Torture.

Our goal was to draw attention to the human rights crisis in Belarus. In order to maximize the outreach and spread the word to as many people as possible, we involved partners and held events in Warsaw, Vilnius, Poznan and online.

The Lithuanian Museum of Occupations and Freedom Fights is a former KGB prison. We put loudspeakers in the «cells» of the museum, in which we played pieces of stories of Belarusians who had experienced torture. All the stories were documented by the <u>International Committee for the Investigation of Torture in Belarus</u>, a special project of ours. During the sound installation, visitors could sense what thousands of Belarusians have gone through.

Actress Krystyna Drobysh, journalist Siarhei Shupa, sound engineer Valeria Auchynnikava, and musician Pavel Haradnitski contributed to the recording of the stories.

### Performance show "375 0908 2334. THE BODY YOU ARE CALLING IS CURRENTLY NOT AVAILABLE"

The performance show "375 0908 2334. The body you are calling is currently not available" was created by Ihar Shuhaleyeu and his team as a protest against repression, dictatorship, fear and stress. It is a kind of invitation to feel yourself imprisoned in Belarus, to physically experience the disempowerment that more than 40 thousand Belarusians have gone through and are still going through every day.

On June 20, we published a new investigation about the torture in Sovetskoye District Police Department of Minsk, which took place from August 9 to 13, 2020. As part of the Week against Torture, we held a closed conference for journalists, where we spoke about the main findings of the investigation.

### Online lecture by Imke Hansen "How to Support People with Experience of Torture"

Imke Hansen, PhD, Germany, is a trauma therapist and a human rights activist with experience in providing psychosocial support on the frontline in Ukraine and in the context of repression in Belarus. In her lecture, Imke shared insights on how we can become more aware and responsive to torture survivors.

# Global Conference of Investigative Journalists in Gothenburg

The Global Investigative Journalists unites Network, GIJN. 244 nongovernmental organizations in countries. All network members support and promote investigative journalism. One of GIJN's goals is to develop implement best practices in the field of investigative iournalism. This conference gathered a record number of participants — over 2000 people from 130 countries.

We took part in the conference to gain new knowledge and share experiences with colleagues from international organizations. All to make our investigations even better and to ensure accountability for any perpetrators of mass torture.

#### **International Congress of Belarusian Studies**

The Congress was founded by representatives of the Belarusian and Lithuanian public as an annual public event targeting experts, journalists, public figures, and students from Belarus and other countries.

This year we presented a special project "Would Tsimur have gone to war if not for August 2020?" at the Congress within the civil society research section.

#### The Week for Equality and Inclusion

The Week for Equality and Inclusion is held annually as part of the Different-Equal information campaign initiated by the human rights organization Human Constanta. This year the organizers suggested to look at equality and inclusion from different angles.

The topics of equality and inclusion are important to us. This year we published a report on "Torture of LGBTQ+ people and the regime's homophobic policies". We were happy to endorse the Week.

# SPECIAL PROJECT OF THE INTERNATIONAL COMMITTEE FOR THE INVESTIGATION OF TORTURE IN BELARUS

The International Committee for the Investigation of Torture in Belarus works with the goal of documenting as many cases of torture as possible, preserving the evidence until fair courts can be established, in order to hold the guilty parties accountable in the future.

#### THE INTERNATIONAL COMMITTEE (IC):

· Collects evidence of crime

Documents and compiles victims' stories into a single database.

 Fights for the rights of those who have suffered at the hands of state agents

Helps to build cases in other countries through universal jurisdiction mechanism.

Reports on developments in Belarus

Produces reports and carries out investigations based on the stories collected and documented.

#### Documenting

Documentation is the most important and extensive part of the work of the International Committee. We strive to prove that the mass torture of civilians that took place in Belarus in the year 2020 and continues to this day constitutes a crime against humanity and must be punished under both domestic and international law.

We are collecting evidence and documenting the stories of survivors in order to ensure accountability for every guilty representative of the authorities and power structures.

#### Investigations, reports, special projects

We believe that talking about what is happening in Belarus is no less important than collecting and documenting information about it. The world community should know that torture does not stop in our country. Just as Belarusians themselves should not forget it.

Investigations and reports are our main tool to expose the developments in Belarus. We analyze hundreds of cases in order to draw a real picture of what is happening and to show it to the public.

Our main task is to reconstruct the events of August 2020, to preserve all the evidence of the crimes and the names of the perpetrators. To show the perpetrators that we know what they did. To let the regime know that we will not forget or forgive anything.

#### Public Inquiry "Mass Torture in the Offenders Isolation Center of Minsk on August 9 - 14, 2020"

We studied **101 stories** — over **1000 pages of text** Each witness was personally present in Akrestsina on August 9-14 and went through this hell.

Based on their stories, we conducted a <u>civil investigation</u> — we established a chronology of events, identified the law enforcement officials who committed the crimes, and made a legal assessment of their actions.

## Public inquiry "Sovetskoye RUVD of Minsk. Torture of detainees in August 2020"



We reviewed **52 documented cases** for this **study.** There are **568 pages of text** and **137 pages of medical certificates and documents.** On the basis of these materials, we created a chronology of events and identified the law enforcement officers involved in the torture of peaceful citizens in the Sovetskoye District Police Department of the city of Minsk on August 9-13, 2020.

# Report "Torture of LGBTQ+ People and the Regime's Homophobic Policies"

The rights of LGBTQ+ people have been systematically violated in Belarus, but the situation has dramatically worsened since the August 2020 elections. The **report** presents evidence of systematic mass discrimination and torture against LGBTQ+ people, and describes the lack of protection mechanisms for vulnerable groups in Belarus.

# Information and analytical review "Political killings and deaths perpetrated by the regime"



On November 12, 2023, the day of Raman Bandarenka's death, we published an **informational and analytical review** of deaths that occurred at the hands of the regime. We analyzed **16 deaths** that occurred during and after the 2020 protests. In each case, we review the circumstances and possible causes of death and, where possible, list the alleged perpetrators.

# Special Project "Would Tsimur have gone to war if not for August 2020?"

In this **paper** we tried to investigate the impact of the events after the 2020 elections in Belarus on the decision of Belarusian volunteers to engage in military action on the side of Ukraine after the beginning of Russia's full-scale invasion. Based on the analysis of the responses of the 15 volunteers interviewed, the project team, which included two psychologists, concluded that the post-election events had a significant impact on their decision to become volunteer fighters.

It is too early to know what long-term effects the events in both Belarus and Ukraine may have on the mental state of the volunteer fighters, as they have not yet ended and a full study, as well as possible treatment, is not yet possible.

#### Universal Jurisdiction

Mass torture, when committed as part of a widespread or systematic attack against the civilian population, is a crime against humanity. This year, for the first time, the United Nations officially **equated** mass torture in Belarus with crimes against humanity.

Atrocities of this magnitude affect everyone. Therefore, thanks to the principle of universal jurisdiction, any country can prosecute and punish them. Anyone who has been mistreated because of his or her political views can turn to the law enforcement authorities of another country.

We help victims submit their stories to the joint investigation — we document, collect evidence, file paperwork, pay for travel and lodging, and arrange for legal counsel.

#### Accountability

The Belarusian regime is leaving its citizens with fewer and fewer opportunities to protect their rights at the international level. In late 2022, Belarus denounced the Optional Protocol to the International Covenant on Civil and Political Rights. This means that victims of human rights violations in Belarus no longer have the opportunity to submit complaints to the Human Rights Committee.

But this is no reason for us to give up! We are looking for new ways to use international mechanisms to protect human rights. In 2023, we began working with the Committee on the Elimination of Discrimination against Women.

We analyzed our documented cases of women survivors of torture and ill-treatment to begin the process of applying to CEDAW.

Workout materials

Our work with victims of torture and ill-treatment is of a long-term nature — due to the nature of international mechanisms, it can take years for the first results of the documentation and investigation of cases under universal jurisdiction to emerge.

We thought a lot about how we could help the victims without duplicating the initiatives that already exist and came up with a mini-campaign — we created a **memo for political prisoners how they can work out** in pre-trial detention centers and partnered with initiatives that send letters to political prisoners.

The flyer was developed with a professional trainer, taking into account the conditions of confinement — limited space, low oxygen concentration, lack of sports equipment.

The flyer is posted on the International Committee's website so that anyone can copy the text and attach it to their letter. The design uses simple drawings that are easy to redraw. The site also has a printable version without logos or identifying marks to increase the likelihood of getting past censors.

#### Working with international organizations

As part of the activities of the International Accountability Platform for Belarus, we continued to support the OHCHR Examination of the human rights situation in Belarus in its third term, following the renewal of its mandate by the UN Human Rights Council.

The Platform provided the OHCHR Examination with access to **294 victims/survivors** and other witnesses from Poland, Lithuania, Georgia and the Czech Republic (180 men and 114 women) and handled the logistical issues necessary to interview some of them.

#### Research

We are always happy to help our colleagues to help improve the work in the human rights sector. That is why in 2023 we took part in 2 studies carried out by the Belarusian Helsinki Committee.

#### Human Rights Index

Legal Initiative experts participated in the assessment of compliance with the Right not to be subjected to torture or cruel, inhuman or degrading treatment or punishment.

#### INTERNATIONAL ADVOCACY

# 52nd Session of the UN Human Rights Council: Side Event "Accountability for International Crimes and Serious Violations of Human Rights in Belarus"

Viktoria Fiodarava, Chair of the Legal Initiative and co-founder of the International Committee for the Investigation of Torture in Belarus, spoke at the <u>52nd session of the UN</u> Human Rights Council. In 2020, the Human Rights Council has already addressed the critical situation in Belarus. However, the current regime has not taken any measures to remedy the situation.

On March 2nd, the 52nd annual session of the Human Rights Council was held, where Belarusian human rights activists stated the need for international attention to the situation in our country.

#### Victoria Fiodarava stated:

"In 2022, the human rights crisis has deepened. We have seen the normalization of torture and ill-treatment, mass persecution of all those suspected of dissent. The Belarusian authorities contributed to the Russian aggression against Ukraine. The position of the Belarusian society against the war was confirmed by the anti-war protests. Arrests, torture and ill-treatment became the order of the day. Recently, we learned that human rights activist Nasta Loika was tortured with a stun gun. Belarus' human rights crisis did not stop in 2020. These are ongoing international crimes."

# OSCE Conference in Warsaw: iSANS Side Event on bringing to justice those responsible for crimes against Belarusians and Ukrainians

On October 3, Viktoria Fiodarava represented the Legal Initiative at the <u>OSCE</u> <u>conference</u> in Warsaw. She focused on the continued impunity of Lukashenka's criminal regime, which remains a serious obstacle to ending repression in Belarus, ensuring justice for victims, and achieving democratic transformation in the country.

Victoria noted that the International Accountability Platform for Belarus has already collected 17,000 documents from more than 2,200 victims and witnesses and 600,000 files from open sources. These materials are being analyzed with the aim of identifying victims and witnesses who can provide information and evidence to criminal justice authorities and the UN examination.

## High-Level Forum on Defending Against Authoritarianism "Future of democracy"

On November 9-10, Vilnius hosted the <u>third High-Level Forum on the Future of Democracy</u>, bringing together democracy advocates from around the world. The focus of the event was on the most serious challenges to democracy today and possible responses to growing authoritarian pressures.

At the meeting, Victoria Fedorova, a representative of the Legal Initiative, spoke about the needs of democratic activists who work under restrictive conditions. She also discussed the methods of support from state and international organizations in critical situations, such as imprisonment, exile, and lack of necessary material resources. Issues of cooperation between activists from different regions working under various conditions were also addressed.
